Resolution 2012-12

At a meeting of the Danville Urbanized Area Metropolitan Planning Organization (MPO), held on September 26, 2012, the following Resolution was adopted:

WHEREAS, the Danville MPO has advertised a public hearing with a series of public notices to inform the public, agencies and organizations, including disabled persons, and transportation providers, of an opportunity to provide comment and input on the Amendment to the FY 2012 – 2015 Transportation Improvement Program, which allows for the addition of: vehicle replacement, computer equipment and software, security equipment, fareboxes, passenger bus shelters, facility and vehicle improvements, and capital assistance for preventative maintenance expenses for Danville Transit Services, as well as a five-passenger minivan with ramp for Danville-Pittsylvania County Community Services; and

WHEREAS, the Danville MPO has held a public hearing combined with public and direct notices to inform the public, public and private agencies, and private enterprise providers, of an opportunity to provide comment and input on the Amendment to the FY 2012 – 2015 Transportation Improvement Program, including a direct mailing of an information letter on the revision to area churches, to the private enterprise providers, and to public, not-for-profit, community based agencies prior to the public hearing; and


WHEREAS, the Danville MPO has endeavored to receive, record, and recognize any comments and input from the public at the open hearing;

NOW THEREFORE BE IT RESOLVED that the Danville MPO shall proceed toward utilizing input and comments in the Amendment to the FY 2012 - 2015 Transportation Improvement Program as deemed appropriate and shall include documentation of the public hearing into the MPO's records as appropriate.



WHEREAS, in order for the Danville (Pittsylvania) Metropolitan Planning Organization to maintain its compliance with the spirit and letter of the Acts of the United States, most particularly the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) (Pub. L. 109–59, August 10, 2005), and

WHEREAS, the Danville MPO has proceeded to review and amend the FY 2012 – 2015 Transportation Improvement Program, which allows for the addition of: vehicle replacement, computer equipment and software, security equipment, fareboxes, passenger bus shelters, facility and vehicle improvements, and capital assistance for preventative maintenance expenses for Danville Transit Services, as well as a five-passenger minivan with ramp for Danville-Pittsylvania County Community Services, employing input from the public, representatives of the MPO, the Virginia Department of Transportation, and Federal agencies' staff members who provided critiques and suggestions;

NOW THEREFORE BE IT RESOLVED that the Danville MPO hereby amends the FY 2012 – 2015 Transportation Improvement Program after exposing said document to a public involvement and participation process including public hearing.
